Subject: Your application for access to documents – ref. GESTDEM 2022/4966

Dear Madam.

I refer to your e-mails dated 21/09/2022 in which you make requests for access to documents, registered on the same date under the above-mentioned reference number.

You request access to: 'Documents regarding Temporarily Reintroduced Border Controls in Sweden for the period 2016 to present. Including reports from Sweden regarding prolongation of temporary reintroduced border controls'.

We identified the following documents that match the requested criteria: (See annex: Detailed list of documents).

Since these documents originate from a Member State, the originator of the documents have been consulted and agreed with their disclosure with the exception of personal data, which has to be protected in accordance with Article 4(1)(b) (protection of privacy and the integrity of the individual) of Regulation (EC)  $n^{\circ}1049/2001$ .

With regard to the above documents, a complete disclosure of the identified documents is prevented by the exception concerning the protection of privacy and the integrity of the individual outlined in Article 4(1)(b) of Regulation (EC) No 1049/2001, because they contain the following personal data, such as handwritten signatures of natural persons.

Article 9(1)(b) of the Data Protection Regulation does not allow the transmission of these personal data, except if you prove that it is necessary to have the data transmitted to you for a specific purpose in the public interest and where there is no reason to assume that the legitimate interests of the data subject might be prejudiced. In your request, you do not express any particular interest to have access to these personal data nor do you put forward any arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Consequently, I conclude that, pursuant to Article 4(1)(b) of Regulation (EC) n°1049/2001, access cannot be granted to the personal data contained in the requested documents, as

the need to obtain access thereto for a purpose in the public interest has not been substantiated and there is no reason to think that the legitimate interests of the individuals concerned would not be prejudiced by disclosure of the personal data concerned.

Therefore, you will find the disclosed documents redacted.

Please note that documents originating from third parties are disclosed to you based on Regulation (EC) No 1049/2001. However, this disclosure is without prejudice to the rules on intellectual property, which may limit your right to reproduce or exploit the released documents without the agreement of the originator, who may hold an intellectual property right on them. The European Commission does not assume any responsibility from their reuse.

In case you would disagree with this position, you are entitled, in accordance with Article 7(2) of Regulation (EC) No 1049/2001, to submit a confirmatory application requesting the Commission to review this position.

Such a confirmatory application should be addressed within 15 working days upon receipt of this letter to the Secretariat-General of the Commission at the following address:
