Registration is open from 20th February 2013 until 26th March 2013. You are kindly requested to complete the registration in respect of all delegates attending the Informal Ecofin, including Heads of Delegation online at:

Please note that your <u>username</u> has been issued to you with the official invite, and is on page one of the Practical Information booklet. <u>Both the username and password are required to register delegates for the event.</u>

General Accreditation Information:

Please note that the size of each Member State's delegation is limited to a maximum of **8.** The Informal ECOFIN delegation is invited in the format 2+ 6 i.e. 1 Head of Delegation from the Ministry of Finance, 1 Head of Delegation from the Central Bank, and up to 6 delegates (to include one deputy Head of Delegation if necessary). The 8 person maximum per delegation does not include spouses of Heads of Delegation or personal security personnel.

The 2 Heads of Delegation will each receive a pin. The Deputy Head of Delegation will receive a red badge (Please note: It is important to select "Delegate Official" on the Accreditation Website for the Deputy Head of Delegation in order to ensure that he/she receives the appropriate red badge), and remaining delegates will receive blue badges. In addition, 1 floater badge will be provided for each delegation. Pins, red badge and floaters allow access to the main plenary hall in the Printworks Building. Blue badges permit entrance to the Print Works Conference Centre lobby and to the Salle d'Écoute.

Any loss of pin or badge must be reported immediately to the liaison officer.
