As mentioned in our meeting a few weeks back, the H&M Group together with a broad group of stakeholders is today calling for **establishing EU-wide harmonised rules for Extended Producer Responsibility for textiles, apparel and footwear** – you might have already seen the stakeholder letter in your inboxes via the Policy Hub this morning, but please also see reattached from our side. The H&M Group fully supports the content of the letter i.e. EU wide harmonised rules for EPR will be a key enabler for building a circular and sustainable fashion and textile sector in Europe.

Together with the Policy Hub, Bureau for Internal Recycling (BIR), Circle Economy, The European Apparel and Textile Confederation, the European Recycling Industries' Confederation (EuRIC), EuroCommerce, the Government of Catalonia, and the Municipality of Milan – we urge the EU Commission, to develop EU-harmonised rules for Extended Producer Responsibility in the EU for apparel and footwear. From our point of view, this will be a key success factor to include in the upcoming EU Textile Strategy.
