It extends the rules on mutual recognition to all judgments on parental responsibility and introduces specific provisions on visiting rights and child abduction. The "exequatur" procedure is abolished for visiting rights and decisions ordering the return of an abducted child. It creates a system of co-operation between central authorities.	The Regulation will apply as of 1 March 2005.
