I would very much appreciate the opportunity to speak with you bilaterally in the next weeks to clarify our position on the issue of forest biomass. We very much recognise that this is a complex issue in terms of a regulatory approach, and as Fern we've attempted to take a science-based position that remains constructive in the light of political dynamics.

We've produced some useful analysis in the last year, on state aids, the relevance of the LULUCF regulation and on the NECPs (forthcoming), that I would be happy to summarise to you in relation to our take on possible solutions.
