Dear Mr Canton,

I am writing to you on behalf of **Enterprise Rent-A-Car, Michelin, and Munic Car Data** to kindly request a meeting with you, or a member of Commissioner Breton's cabinet, in light of the European Commission's upcoming presentation of the **initiative on access to in-vehicle data**, a sector specific legislation to complement the currently discussed Data Act.

Enterprise, Michelin and Munic welcome this initiative as a **fundamental and much-needed component of the Commission's wider strategy for data, mobility and green transition**. The initiative will be vital to ensuring the success of Europe's mobility ecosystem in an increasingly data-led economy, **seeing Europe take the global lead** in defining an effective framework for a level playing field for mobility service providers across the ecosystem, and **addressing well-documented gatekeeper issues** pertaining to data access.


In the current absence of regulation, **car data is a major consumer problem**: cars are sharing a growing amount of data, but consumers have no control over it, being locked into systems and unable to make informed alternative choices. At the same time, **fair access to data is key to the decarbonisation of the transport sector**, as consumers need to be able to seamlessly access charging infrastructure and have full access to options to lower their carbon footprint.

We understand that the Commission expects to finalise preparations for the initiative's release, including the submission of an impact assessment, early next year. In light of this, **would you be available for a meeting to discuss this issue further, at your earliest convenience in the coming weeks?**

We very much appreciate your time and kind consideration of this request, and we look forward to hearing from you.
