Please find enclosed former Commissioner Andris Piebalgs' e-mail sent to me on 19 November 2014 notifying the Commission about two occupations which he envisages to engage in, namely with the Global Fund and as Guest Lecturer in the University of Latvia.

Mr Piebalgs clarified later that he is intending to join the Friends of the Global Fund Europe but not the Global Fund's International Board (see also his e-mail of 21 November to D. Claeys Boúúaert).


