Subject: Application of the procedure with associated committees under Rule 50 on the proposal for a Regulation amending Regulation (EC) No.443/2009 to define the modalities for reaching the 2020 target to reduce CO2 emissions from new passenger cars (COM(2012)0393 - 2012/0190 (COD))

We are pleased to inform you that following negotiations between the Rapporteurs of the Environment, Public Health and Food Safety (ENVI) and the Industry, Research and Energy (ITRE) Committees, an agreement has been reached on the application of Rule 50 on the above proposal.



ANNEX: Joint competence:

1. The ITRE Committee will have joint competence on:

- **Article 2(4)** (derogations for certain manufacturers - as amended by Article 1(2) of the proposal); and

- **Recitals 4, 5 and 6**

2. The ITRE Rapporteur will be invited to ENVI shadows meetings and to any trilogues taking place in the context of legislative negotiations in relation to the proposal.

3. The ITRE Rapporteur will receive from the ENVI Committee copies of all relevant documentation associated with any such trilogues.
