#### I. DRAFT ANNOTATED AGENDA

1. Information exchange mechanism on export control issues with countries aligning with the Common Position (cf. COARM DS 07/2011)

Delegations will be invited to exchange views with representatives of South Eastern European countries on the EU proposal tabled in 2011 to set up an information exchange mechanism on export control issues with third countries that have aligned with Common Position 2008/944/CFSP, DELETED

### 2. Outreach activities under Council Decision 2009/1012/CFSP and way forward

(i) Exchange of views with representatives of South Eastern European beneficiary countries under Council Decision 2009/1012/CFSP

The Group will exchange views with representatives of South Eastern European beneficiary countries under Council Decision 2009/1012/CFSP on the assessment of EU outreach activities implemented to date, and on the elaboration of future EU activities in the field of arms export controls covering South Eastern Europe.

The Group will have an exchange of views on the Head of Secretariat issue following the extraordinary Wassenaar Arrangement Plenary Meeting held on 16 March 2012 in Vienna.
