Subject: Your application for access to documents – Ref GestDem No 2016/6680

Dear Ms da Silva,

I refer to your email of 25 November 2016 in which you make a request for access to documents under Regulation (EC) No 1049/2001¹ ("Regulation 1049/2001"), registered on 28 November 2016 under the above mentioned reference number.

You requested access to *"all exchanges between then Commissioner Karel De Gucht, his office and his Cabinet, with ArcelorMittal from 1 February 2010 to 31 October 2014"*. You specified that you *"would like to request any emails, correspondence, meeting notes or telephone call notes"*.

We have identified the following documents that fall under the scope of your request:

- A meeting request from ArcelorMittal dated 8 June 2010 (CABDEGUCHT/2010/A/1106) ("**document 1**");
- A meeting request from ArcelorMittal dated 4 October 2012 (Ares(2012)1165730) ("**document 2**");
- An email from ArcelorMittal Poland ("**document 3**") including a letter from ArcelorMittal Poland and two other companies in attachment ("**document 3.a**"), both registered under the same reference number (Ares(2013)3130561);

- A letter from former Commissioner Karel De Gucht replying to the letter contained in document 3 (Ares(2013)3391009) ("**document 4**");
- A letter from ArcelorMittal Poland and two other companies replying to the letter contained in document 4 (Ares(2013)3507741) ("**document 5**");
- An email from EUROFER to former President Barroso and other Commissioners dated 28 February 2014 ("**document 6**"), including an open letter signed by ArcelorMittal ("**document 6.a**"), both registered with the same reference number (Ares(2014)544467);
- An email from ArcelorMittal Business Division North dated 5 March 2014 ("**document 7**"), enclosing in attachment an open letter in Dutch ("**document 7.a**") and in English ("**document 7.b**"), all registered with the same reference number (Ares(2014)608467);
- An email from EUROFER to all Commissioners dated 25 September 2014 ("**document 8**"), that includes an open letter signed by ArcelorMittal ("**document 8.a**"), both registered with the same reference number (Ares(2014)3173220).

I am glad to inform you that full access can be granted to the content of the documents listed above. However, some personal data have been withheld in accordance with Article 4(1)(b) of Regulation 1049/2001. In line with the Commission's commitment to ensure transparency and accountability², the names of the members of Cabinet are disclosed, as well as the names of the senior management of the Commission (Director level and above). For ArcelorMittal and other companies, the names of the CEOs, Presidents, Directors or equivalent are also disclosed. Copies of the accessible documents are enclosed.

Article 4(1) (b) of Regulation 1049/2001 provides that *"[t]he institutions shall refuse access to a document where disclosure would undermine the protection of: [...] privacy and the integrity of the individual, in particular in accordance with Community legislation regarding the protection of personal data"*.

The applicable legislation in this field is Regulation (EC) No 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data³.

The Court of Justice has ruled that *"where an application based on Regulation 1049/2001 seeks to obtain access to documents containing personal data" "the provisions of*

*Regulation 45/2001, of which Articles 8(b) and 18 constitute essential provisions, become applicable in their entirety"*⁴.

Article 2(a) of Regulation 45/2001 provides that *"'personal data' shall mean any information relating to an identified or identifiable natural person [...]"*. The Court of Justice has confirmed that *"there is no reason of principle to justify excluding activities of a professional [...] nature from the notion of 'private life'"*⁵ and that *"surnames and forenames may be regarded as personal data"*⁶, including names of the staff of the institutions⁷.

In accordance with Article 8(b) of this Regulation, personal data shall only be transferred to recipients if they establish *"the necessity of having the data transferred"* and additionally *"if there is no reason to assume that the legitimate interests of the data subjects might be prejudiced"*. The Court of Justice has clarified that *"it is for the person applying for access to establish the necessity of transferring that data"*⁸.

I consider that you have not established the necessity of having the aforementioned personal data transferred to you. Moreover, it cannot be assumed on the basis of the information available, that disclosure of such personal data would not prejudice the legitimate interests of the persons concerned. Therefore, these personal data shall remain undisclosed in order to ensure the protection of the privacy and integrity of the individuals concerned.

You may reuse the documents free of charge for non-commercial and commercial purposes provided that the source is acknowledged and that you do not distort the original meaning or message. The Commission does not assume liability stemming from the reuse.

In case you would disagree with the assessment that the withheld data are personal data which can only be disclosed if such disclosure is legitimate under the rules of personal data protection, you are entitled, in accordance with Article 7(2) of Regulation 1049/2001, to make a confirmatory application requesting the Commission to review this position.

Such a confirmatory application should be addressed within 15 working days upon receipt of this letter to the Secretary-General of the Commission at the following address:
