Patient Safety and Quality of Care -EU action-

- **Sharing knowledge and experience *e.g.***
 - ✓ **EU Expert Group on Patient Safety and Quality of Care**
 - Set up in 2005 ("Working Group on Patient Safety")
 - Chaired by Poland
 - EU Member States, International Organizations, EU Stakeholders
 - Exchange of information and experience
 - Consulted on current and planned activities
 - Produces reports at EC's request or on its own initiative (*e.g.* reports on education and training of health professionals in Patient Safety and on reporting and learning systems for Patient Safety incidents)
 - ✓ **EU Network on Patient Safety and Quality of Care (PaSQ joint action)**





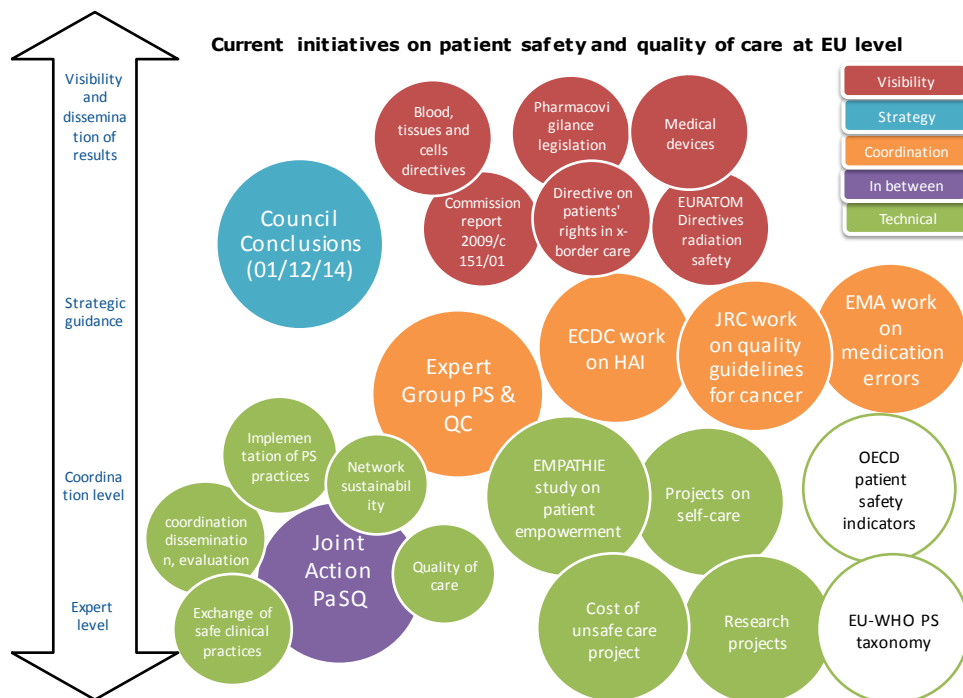
Patient Safety and Quality of Care -EU action-

➤ **Classifying and measuring patient safety e.g.**

- ✓ OECD (Health Care Quality Indicators)
- ✓ WHO (Patient Safety Taxonomy)

➤ **Develop and promote research e.g.**

- ✓ Projects under the Health Programme and Research programme



Future activities in the field of Patient Safety and Quality of Care



Patient Safety and Quality of Care -Future activities-

Objective:

Develop, by December 2016, a framework for a **sustainable EU collaboration** on Patient Safety and Quality of Care in order to:

- facilitate mutual learning and exchange of good practices and strategies between Member States
- better coordinate patient-related policies
- facilitate the move from policies to practical implementation





Patient Safety and Quality of Care -Future activities-

Background:

- 2nd Commission report on the implementation of the Recommendation 2009/C 151/01 : *"a vast majority of stakeholders believe that there would be added value in setting up a **permanent European forum** to promote and share best practice in the field of patient safety and quality of care"*



Patient Safety and Quality of Care -Future activities-

Background:

- Council Conclusions on Patient Safety and Quality of Care of 1 December 2014 : *"invite the Member States and the Commission to set up, by December 2016, a framework for a **sustainable EU collaboration** on patient safety and quality of care"*





Patient Safety and Quality of Care -Future activities-

Background:

- European Union Network for Patient Safety and Quality of Care (PaSQ Joint Action): *"calls for a **permanent network** on Patient Safety and Quality of Care involving Member States and European stakeholders"*

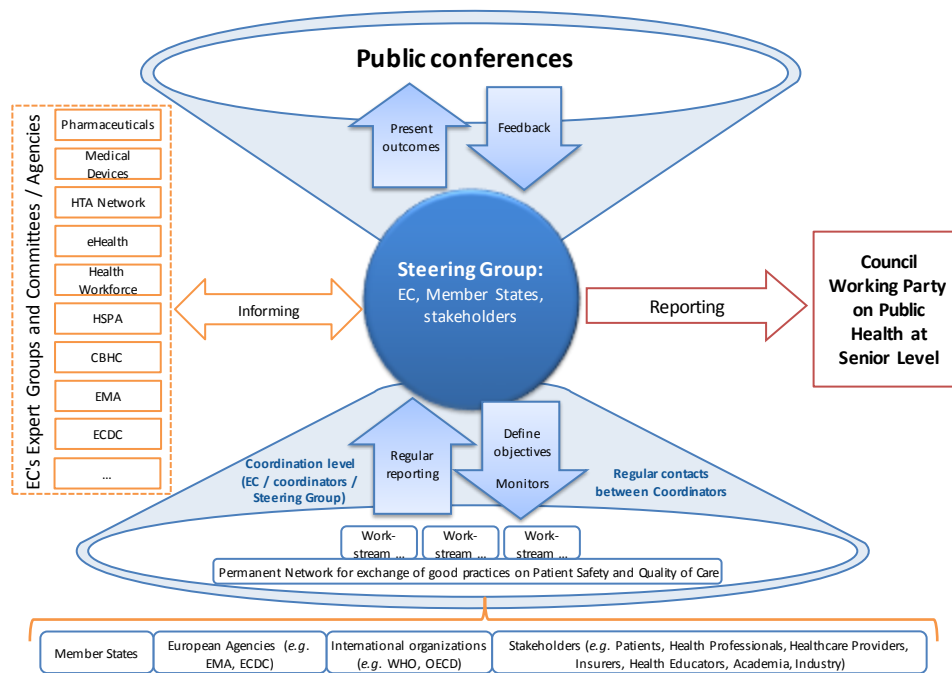


Patient Safety and Quality of Care -Future activities-

Background:

- European Parliament report on "safer healthcare in Europe: improving patient safety and fighting antimicrobial resistance", voted on 19 May 2015, *"calls on the Commission and the Member States to further engage in a dialogue with all stakeholders and develop a coordinated, **comprehensive and sustainable EU strategy** for patient safety"*





Patient Safety and Quality of Care -Future activities-

- **11 February 2015:** 1st discussion in the EU Patient Safety and Quality of Care Expert Group, followed by 4-week written consultation
- **8 June 2015 :** 2nd discussion in the EU Patient Safety and Quality of Care Expert Group
- **15 July 2015:** Exchange of views in Council Working Party on Public Health at Senior Level

= still under discussion
