Meeting of 17 September 2012, from 15.00 to 18.30,  
and 18 September 2012, from 9.00 to 12.30

BRUSSELS

*The meeting opened at 15.07 on Monday 17 July 2012, with Evelyn Regner (First Vice-Chair) in the chair.*

**1. Adoption of agenda**

The Chair announced that item 26 "Presentation of DG for Communication's activities and tools for committees" was postponed. The agenda was adopted as amended.

**2. Chair's announcements**

The Chair proposed that the deadline for amendments should be set for the following dossiers at Friday 28 September 2012, at noon:

- 28th annual report on monitoring the application of EU law, rapporteur Mrs Lichtenberger.

- Proposal for a Directive of the European Parliament and of the Council amending Directive 2003/98/EC on re-use of public sector information (opinion to ITRE), rapporteur Mrs Gallo.

The deadline for amendments for the Award of Concession Contracts: Rapporteur Raffaele Baldassarre, should be set on Monday 24 September 2012, at noon.

The Chair announced that JURI and EMPL had agreed on a time-table under Rule 50 for the following two own-initiative reports: Corporate Social Responsibility: accountable, transparent and responsible business behaviour and sustainable growth (JURI lead committee), rapporteur Raffaele Baldassarre, and Corporate Social Responsibility: promoting society's interests and a route to sustainable and inclusive recovery (opinion to EMPL), rapporteur for opinion Raffaele Baldassarre.

The deadline for amendments for both the report and the opinion should be set at 29 November 2012, at noon.

The Chair also announced that a timetable has been agreed with DEVE for the opinion on Development aspects of intellectual property rights on genetic resources: the impact on poverty reduction in developing countries, rapporteur Françoise Castex. No exchange of views will be held and the consideration of draft report will take place at the JURI meeting in October.

Concerning the JURI delegation visit to China, it is to be noted that the Conference of Presidents authorised on 13 September 2012 the Delegation for relations with the People's Republic of China to also make a delegation visit to China at the same time.

The decision states that the two delegations shall "collaborate in the organisation of their visits". The information thus far communicated is therefore only provisional pending coordination between the relevant services of the Parliament's administration.

The Committee decided to recommend that Parliament should submit oral observations in Case C-370/12 "*Pringle*" - Preliminary reference from the Irish Supreme Court, concerning the validity of European Council Decision 2011/199/EU amending Article 136 TFEU with regard to a stability mechanism for Member States whose currency is the euro. The committee recommended that the observations should be limited to supporting recourse to the simplified procedure for amending the Treaty; it further recommended that Parliament be represented by the Jurisconsult since the European Council would be represented by the Director General of the Council's Legal Service.

The decision was adopted by 21 votes in favour, 1 against and no abstentions.

#### **Case T-296/12, The Health Food Manufacturers' Association v Commission**
