Article 2 Modifications

The following specifications of the Initial Agreement are modified as follows:

New Article I.2 Duration

- I.2.1. The Agreement shall enter into force on the date when the last of the two parties signs.
- **I.2.2.** The period of eligibility for Community funding shall be 13 months from 01/12/2006 ("the starting date").

NEW ARTICLE I.3.1 Financing the work programme – Total cost

I.3.1. The total costs eligible for Community funding are estimated at EUR 336 450.37 as shown in the Beneficiary's estimated operating budget in Annex II. The estimated operating budget shall show all the operating costs and receipts estimated by the Beneficiary for the period in question, making a distinction between costs eligible for Community funding and those not eligible, in accordance with the definition of eligible costs in Article II.12.

NEW ARTICLE I.3.2 Financing the work programme – Amount of the grant

I.3.2. The Commission shall contribute a maximum of EUR 301 459.53 equivalent to 89.60% of the estimated total eligible costs indicated in paragraph 1. The final amount of the grant shall be determined as specified in Article II.15, without prejudice to Article II.17.

The Community grant may not finance the entire costs of implementing the work programme. The amounts and sources of cofinancing other than from Community funds shall be set out in the estimated budget referred to in paragraph 1.



CONSOLIDATING AND STRENGTHENING A CHILD SPECIFIC APPROACH TO COMBATTING CHILD POVERTY AND SOCIAL EXCLUSION OF CHILDREN IN THE **EUROPEAN UNION**

I would like to request approval of two changes to the Work Programme that have been highlighted in our approved progress report (submitted 16th July 2007).

Objective 1: Coordination, management & strengthening of the network

It was foreseen to develop a common Eurochild policy paper with contributions from members. In view of the difficulty to achieve consistent quality and depth, and the policy needs of Eurochild, it was decided to contract an external expert to support the drafting of a paper on "a child rights approach to child poverty". This work will slightly increase the costs of external consultant's inputs and reduce members' contribution to the Eurochild work programme. Overall expenditure remains in line with the original budget.

Objective 2: To contribute to, influence & monitor policy development

Eurochild's work programme foresaw the production of a booklet (12-16 pages) to publicise the results of the NAPs analysis and the key messages for implementation. Instead Eurochild would like to publish a flyer of 6-pages including facts and figures on the situation in the EU and also a background to the OMC on social inclusion. This will be translated into several languages. This will lead to some under-spend in the information dissemination budget.

Furthermore, it has not been possible to be directly involved in the Children's Parliaments as foreseen in the Work Programme. Instead Eurochild proposes to focus on children's participation in the Annual Conference and invite children from different participation structures across the EU to exchange best practice and bring together common principles on inclusion and representation. This will lead to slightly higher travel and accommodation costs for the annual conference. However, overall expenditure under this budget heading remains will remain in line with the original budget.
