I refer to your e-mail of 11/01/2017 through which you request access to documents under Regulation (EC) No 1049/2001 regarding public access to European Parliament, Council and Commission documents<sup>1</sup>. Your email concerns the written observations submitted by the European Commission in cases C-466/12<sup>2</sup>, C-348/13<sup>3</sup>, C-160/15<sup>4</sup> and C-138/16<sup>5</sup>.

As you were informed, the Commission's observations in case C-160/15 are already public<sup>6</sup>. With regards to the Commission's written observations in cases C-466/12 and C-138/16, after a concrete assessment of the above mentioned documents, I am pleased to inform you that access can be granted. However, parts of the documents have been expunged since they must be protected under the exception for the protection of commercial interests, as will be analysed below.
