O Manufactured Tobacco List Price Law (Law No. 122 of June 3, 1965; as amended)

Final Amendment: March 31, 1983

(Types and maximum prices of manufactured tobacco)

Article 1 The types of manufactured tobacco (hereinafter referred to as the "Manufactured Tobacco") manufactured by the Japan Tobacco and Salt Public Corporation (hereinafter referred to as the "Corporation") shall be cigarettes, flaked tobacco, pipe tobacco and cigar tobacco, and the maximum prices by grade for each of these types are stipulated as follows.

2. Notwithstanding the provisions of the preceding paragraph, if the Corporation manufactures cigarettes that are prepared by using particularly high quality leaf tobacco as the main raw ingredient and combining it with other carefully selected raw leaf tobacco to produce a high grade brand which maintains distinctiveness and character, then the maximum price of that product shall be 190 yen per ten cigarettes.

Article 4 When the Corporation determines and gives public notice of the list prices of the Manufactured Tobacco pursuant to Article 34, Paragraph 1 of Tobacco Monopoly Law (Law No. 111 of 1949; as amended), the Corporation shall concurrently publicize types, grades and standard specifications of the Manufactured Tobacco.

Supplementary Provisions

1. This law shall come into force from the date of promulgation of the law.
