Subject: Reply to your request for access to documents - ATD/54/2017

Dear Members of the European Parliament,

Thank you for your request of 21 June 2017, registered under reference ATD/54/2017, seeking access to documents. Your request falls under Regulation (EC) No 1049/2001 (the "ATD Regulation") which governs the access to documents held by the European Chemicals Agency¹.

Your request concerns access to:

 assessment of glyphosate which mention Monsanto or the Glyphosate Task Force during
 the year 2016. This includes inter-institutional correspondence, correspondence with
 Member States' authorities and their Permanent Representations as well as

Decision

Based on Article 7(1) of the ATD Regulation

ECHA has decided to:

- grant you full access to the documents 14 and 33-35 listed above;
- grant you partial access to documents 1-13, 15-32 and 36-40 listed above.

Reasons

Documents to be partially disclosed

Following a concrete and individual assessment of the documents requested under the provisions of the ATD Regulation, ECHA has concluded that for the documents 1-13, 15-32 and 36-40, the disclosure is partly prevented by exceptions to the right of access laid down in Article 4 of this regulation.

The explanations set out below describe why specific redactions in the documents indicated above have been performed.

Personal data

All personal data (e.g. names, addresses, emails, indication of country of origin, and phone numbers) potentially allowing the identification of individuals has been redacted from the requested documents as the exception provided by Article 4(1)(b) of the ATD Regulation on the protection of personal data was found to apply.

References to the studies

The names of authors of unpublished studies have been redacted as the exception provided by Article 4(1)(b) of the ATD Regulation on the protection of personal data or by Article 4(2) first indent of the ATD Regulation on the protection of commercial interests was found to apply.



Please note that for all the items listed above no overriding public interest in disclosure was found to exist since the remaining information enables you to have a detailed overview of the context of the opinion making process.

You are reminded that following Article 16 of the ATD Regulation, the documents attached are subject to copyright protection.

Appeal/legal redress

You are entitled to make a confirmatory application requesting ECHA to review this position by writing to the Executive Director of ECHA (P.O Box 400, 00121 Helsinki, Finland or <u>executive-director@echa.europa.eu</u>). This needs to be done within 15 working days of receiving this letter.

The Executive Director will inform you of the result of the review within 15 working days from the registration of your subsequent request.
