Dear Mr Dohle.

This is the follow-up of our replies of 27 June and 19 July 2013 concerning your request related to the comparative study on the adoption procedures in EU Member States.

You have asked access to the "correspondence received by the Commission both from Members of the European Parliament and citizens/associations, in the period between 1/1/2006 and 1/6/2010 to which this study was a follow-up".

With our reply of 19 July 2013 (registered under Ares(2013)3220748), we have already disclosed most of the correspondence related to adoption issues, which was not the subject of other specific requests from you, such as correspondence with associations as Nordic Adoption, Amici dei Bambini, Amici dell'Adozione, Care/Sera, etc... as well as the parliamentary questions and letters from MEPs linked to adoption.

You sent a request for "internal review" on 20 September 2013 to which we answered that "Concerning your request related to GESTDEM 3117/2013, for which you already sent on 20 September a confirmatory appeal, please be aware that you have received most part of the correspondence available to DG Justice already on 19/7/2013.

Moreover, the letters from the associations (like Amici dei Bambini, Amici dell'Adozione, etc) had been the subject of other requests of yours and you have already received the answer. There are still few letters from citizens for which we are collecting the permission to disclose and that will be forwarded to you as soon as possible".
