Thanks for letting me know.

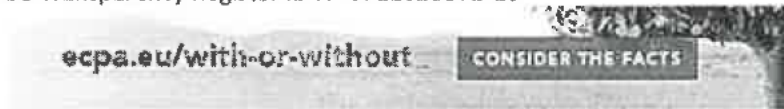
