## Main issues discussed

### Meeting with the Düsseldorf Chamber of Commerce and Industry

#### 5 March 2018

The meeting was requested by Dr. Gerhard ESCHENBAUM, Deputy Executive Director of the Düsseldorf Chamber of Commerce and Industry, and [Art. 4(1)(b)] , both present at the meeting. From the Commission part, the meeting was attended by Ms. Mana MARTIN—PRAT (Director), [Art. 4(1)(b)]

The Düsseldorf Chamber of Commerce and Industry presented a survey of German Business in China 2017/18 (attached).

Ms Martin-Prat appreciated the interest of the Düsseldorf Chamber of Commerce and Industry and clarified that the EU remains open and needs to attract further foreign investment, including from China. The EU screening proposal focuses on national security and public order issues, like in many other countries, including China; it is not a lool of mercantilist policy (national economic interest). The proposal aims to enhance transparency and coordination among the Member States and does not oblige them to set up a screening mechanism if they do not have one. Additionally, she explained the objectives, state of play and the next steps in the ongoing investment negotiations.
