Your application for access to Frontex documents

Dear Mr Semsrott,

In response to your application registered on 14 November 2018, asking for access to

- The 2017 Technical Equipment Pool register, including especially the names, amounts and models of technical equipment, registration numbers as well as member states who committed the respective equipments.
- The Technical Equipment Pool register of October 2018, including especially the names, amounts and models of technical equipment, registration numbers as well as member states who committed the respective equipments,

for the year 2017, kindly refer to the 2017 Annual Information containing all releasable information to be retrieved under: https://frontex.europa.eu/assets/Key_Documents/EBGT_TEP_Report/2017_Frontex_Annual_Report_o n_the_EBCGT_and_the_TEP_operational_resources.pdf

Please find attached the Technical Pool Register for October 2018. Some limited parts of the documents you have applied for fall under an exception to public access to documents as stipulated in Regulation (EC) No 1049/2001¹, and had therefore to be expunged as:

- they contain information regarding the technical equipment deployed in each operational area. Disclosing such information would be tantamount to disclosing the exact type, capabilities and weaknesses of the equipment, as well as their usual position, opening way for abuse. The result of this would only be to hamper the course of ongoing and future similar operations, ultimately obstructing their purpose to counter and prevent cross-border crime and unauthorized border crossings. Consequently, the release of the information contained in the documents would undermine the protection of the public interest as regards public security as stipulated in Article 4(1)(a) first indent of Regulation (EC) No 1049/2001.
- disclosing the redacted parts would influence internal decision-making processes regarding the current and future activities of the Agency and Member States involved. The ongoing discussions taking place within Frontex and under its auspices with the Member States require special protection as disclosing the redacted parts would reveal negotiation positions of the stakeholders and would enable to draw preliminary conclusions. Such action, in turn, would hamper the ongoing negotiations and erode the

mutual trust between the stakeholders. As no overriding public interest in disclosure is ascertainable in this particular case, the release must be refused based on Article 4(3) of Regulation (EC) No 1049/2001.

Kindly be reminded that the copyright of the documents rests with Frontex and that the existing rules on copyright may limit your right to reproduce or exploit the released documents.
