

5. Exchange of views with Art. 4(1)(b) journalist for Art. 4(1)(b)					
During his second invitation to the DHoMs group, journalist Art. 4(1)(b) focused on perspectives for the presidential elections and a possible run-off. According to him, the second round will be a polarised dispute between Bolsonaro and Haddad, with a probable victory for Haddad. During the last 4 elections, whoever won in the first round ended up also winning in the second round. His prediction was for Bolsonaro to attain around 25% of the vote – or less, given lack of TV time and impossibility to participate properly in the campaign. Art. 4(1)(b) did not see other forces, namely PSDB, MDB and centrão, creating a possible cordon sanitaire to contain Bolsonaro since anti-PT sentiment was also very strong.
