I have the pleasure of inviting you to speak at a Social Services Europe debate on **‘The role of Social Services in Implementing the European Pillar of Social Rights’** at the European Parliament. The event will take place on the **24<sup>th</sup> April 2018, between 9.30 and 11.30** and will be hosted by MEP Georgi Pirinski (S&D). It aims to gather key EU policy-makers and stakeholders to discuss the key role of social services for the effective implementation of the principles enshrined in the European Pillar of Social Rights.

The event is organized by Social Services Europe (SSE), the largest European umbrella organisation representing non-profit social and health care providers. Our members -Caritas Europa, CEDAG, EASPD, EPR, Eurodiaconia, FEANTSA, SOLIDAR, Red Cross EU Office- together represent more than 100.000 social and health care providers at the forefront of ensuring accessible, affordable and quality services for all people in Europe.

The proclamation of the European Pillar of Social Rights on 19 November 2017 represented a very important first step for reinforced convergence between Member States towards better working and living conditions in Europe. As the Pillar is entering its key implementation phase, SSE would like to engage into a dialogue with policy-makers to show why social services play an essential role in operationalising the principles in the Pillar and should hence be promoted as key enablers of such goals.

Your participation as speaker would be most welcome in light of the key role that the European Commission still has in bringing the EPSR forward. For this reason, we would like to count with your insight on foreseen EC action, your views on how the implementation should be approached at national level and how partnerships with civil society could be reinforced to this aim. Your intervention would be accompanied by contributions from MEPs, the Presidency of the Council, the Social Protection Committee and SSE representatives. Please find enclosed a draft agenda including the time slot of your intervention (between 10.15 and 10.45am).
