- 2. OLAF final Report in the investigation mentioned at point 8 of the European Parliament resolution of 17 April 2013 with observations forming an integral part on discharge in respect of the implementation of the budget of of its Decision the European Union Agency for Fundamental Rights for the financial year 2011 (C7-0247/2012 - 2012/2185(DEC))"
