We have spoken a few times by phone and we met in December at event regarding PiE hosted by the Brussels pharma law group (thank you for an excellent presentation).

I just saw that the strategic approach to PiE now has been communicated to the EP and the Council, you've obviously been a driving force in its development, so I wanted to congratulate you on this milestone! I am looking forward to reading the final version once it is publicly available.

Also, I am probably late to the party on this one, however, I wanted to understand if you might be interested in presenting at a PiE focused event at FleishmanHillard once the strategy is available? We have a strong network in the sectors relevant to the strategy and we have a tradition for offering a platform to

facilitate dialogue on these types of issues. We often find that this gives a different type of conversation than in trade associations and similar contexts.

I know you and your colleagues in DG ENV have been active at various events so far where you've focused on the approach of the strategy and the potential contents. After the publication of the strategy, my thinking is that it would be interesting to have an event focused more on its 'implementation' and next steps, as there is of course much work ahead. It would perhaps also be interesting opportunity for you to see the reception of the final strategy by the stakeholders and perhaps the nuances between them.
