Hello Everis Team and SANTE organisation,

Thank you for continuing to share your progress with the implementation standards for articles 15 and 16 of the EU TPD, through the workshops you have been holding.

Having attended the workshop in Brussels on May 15th, I noted with interest the suggested structure of the unit pack level Unique Identifier, which appears to be of a new/customised design.

After reviewing the design we also noted that this differs from the GS1 "SGTIN" code construction widely used in the Pharmaceuticals industry in Europe today. Given that the SGTIN is an open standard that is widely understood across a range of industries, and that the success of implementing a Track and Trace scheme will, in part, be reliant on a) consistent implementation standards across supply chains, and b) interoperability of existing and new systems, we wanted to simply highlight that the GS1 SGTIN is an existing standard available today for the unit pack level identifier.

We remain at your disposal to input our views as a solutions provider in this domain.
