The Committee held a first orientation debate as part of the preparations for the EU-Japan Summit to take place in April 2010. Based on the orientation note drafted jointly by the Presidency, the Commission and the General Secretariat of the Council, delegations were briefed on the priorities for the summit and some possible sensitive issues to be expected. Member states offered their suggestions for EU-positions to be formulated during discussions, or in the Summit outcome document. Presidency promised to take delegations' comments on board.

The Presidency informed the Committee about the exchange of views on the most significant issues related to the employment situation of youth in Member States, held during the lunch of the EPSCO Council. Based on a presentation by Commissioner Andor and a Presidency background paper on "Youth Employment Policies", Ministers welcomed the 2 Flagship initiatives under the "Youth on the Move" proposal, in particular to favour youth mobility in the EU.
