I refer to your e-mail of 31 March 2020, registered on the same day, in which you submitted a confirmatory application, in accordance with Article 7(2) of Regulation (EC) No 1049/2001 regarding public access to European Parliament, Council and Commission documents¹ (hereafter 'Regulation (EC) No 1049/2001').

Your confirmatory application was submitted in relation to your initial application of 17 February 2020, addressed to the Directorate- General for Energy, whereby you requested access to, I quote:

As you did not receive the reply from the above-mentioned Directorate-General within the statutory time limits, you submitted, on 31 March 2020, the confirmatory application.

I note, however, that on 7 May 2020, the Directorate-General for Energy provided you the reply to your initial application.

As the Directorate-General for Energy has in the meantime sent you a full reply to your application, the Secretariat-General will close this confirmatory application. Please note that this is without prejudice to your right to submit a new confirmatory application if you do not agree with the position of the Directorate-General for Energy, as reflected in its reply of 7 May 2020.
