Thank you for your letter in which you reiterate your concerns regarding the notification of proposed audit firms.

I would like to inform you that the Commission issued a follow-up letter to manufacturers on 16 December. In this letter, we announced a change to the notification timeline. The new timeline requires manufacturers to notify proposed audit firms within 45 calendar days from the date of publication of the audit guidelines. I trust that the new timeline addresses the concerns that you raise in your letter.

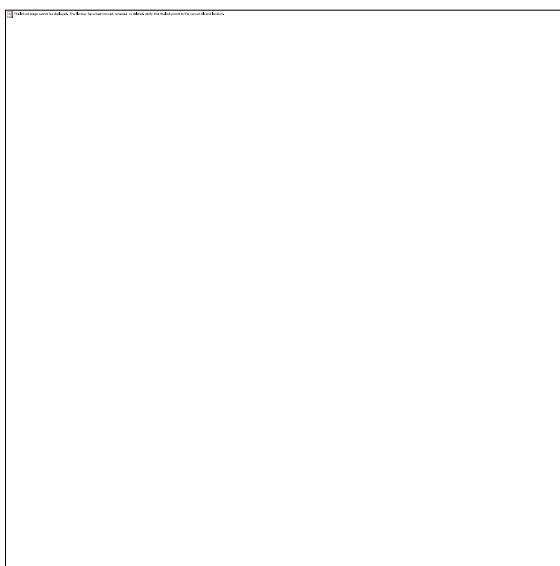

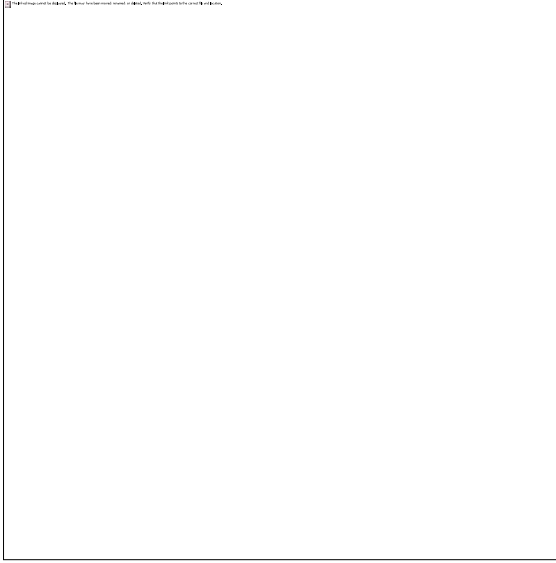
