We are closely following the rapidly evolving situation of COVID-19 outbreaks in EU Member States and other parts of the world.

It is encouraging to see how the European Commission and the relevant EU agencies are closely monitoring and offering guidance on the outbreak. Establishing the EU COVID-19 response team with your colleagues Commissioners Lenarčič, Vălean, Johansson, and Gentiloni especially underlines the need to apply a multi-sector approach to contain the COVID-19 outbreak and its potential impact on EU Member States as much as possible.

On our side, we have been centrally involved in helping governments and multi-lateral institutions shape their response to several global health crises, including SARS, MERS, and Ebola, in recent years.
