Having examined the documents requested under the provisions of Regulation (EC) No 1049/2001 regarding public access to documents, I have come to the conclusion that:

- Documents 1.4, 1.5, 1.6, 1.15, 1.16, 1.18, 13.1, 14.2, 17.2, 20.1, 22.1, 23.2, 27.2, 28.1 and 40.1 may be fully disclosed.
- Documents 1.1, 1.2, 1.3, 1.17, 2.1, 2.2, 3.1, 3.2, 4, 5.1, 5.2, 5.3, 5.4, 6, 7.1, 7.2, 8.1, 8.2, 8.3, 9, 10, 10.1, 11, 11.1, 12, 12.1, 13, 14, 14.1, 14.3, 15, 16, 16.1, 16.2, 17, 17.1, 17.4, 18, 18.1, 19, 19.1, 20, 21, 21.1, 22, 23, 23.1, 24, 24.1, 24.2, 25, 25.1, 26, 27, 27.1, 28, 29, 29.1, 29.2, and 40 may be partially disclosed.

Regarding the documents that may be partially disclosed (namely, documents 1.1, 1.2, 1.3, 1.17, 2.1, 2.2, 3.1, 3.2, 4, 5.1, 5.2, 5.3, 5.4, 6, 7.1, 7.2, 8.1, 8.2, , 8.3, 9, 10, 10.1, 11, 11.1, 12, 12.1, 13, 14, 14.1, 14.3, 15, 16, 16.1, 16.2, 17, 17.1, 17.4, 18, 18.1, 19, 19.1, 20, 21, 21.1, 22, 23, 23.1, 24, 24.1, 24.2, 25, 25.1, 26, 27, 27.1, 28, 29, 29.1, 29.2, and 40 may be partially disclosed), I would like to point out that some parts of the aforementioned documents have been blanked out as their disclosure is prevented by exceptions to the right of access laid down in Article 4(1)(b) and first indent of Article 4(2) of this Regulation. Some of the redacted parts of the documents contain commercially sensitive business information concerning the implementing partner and, hence, article 4(2) of the Regulation is applicable. Additionally, a complete disclosure of the identified documents is prevented by the exception concerning the protection of privacy and the integrity of the individual outlined in Article 4(1)(b) of Regulation (EC) No 1049/2001, because they contain the following personal data:

- the names/initials and contact information of Commission staff members not pertaining to the senior management;
- the names/initials and contact details of other natural persons;
- pictures of natural persons;

other information relating to an identified or identifiable natural person.

Article 9(1)(b) of the Data Protection Regulation does not allow the transmission of these personal data, except if you prove that it is necessary to have the data transmitted to you for a specific purpose in the public interest and where there is no reason to assume that the legitimate interests of the data subject might be prejudiced. In your request, you do not express any particular interest to have access

to these personal data nor do you put forward any arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Consequently, I conclude that, pursuant to Article 4(1)(b) of Regulation (EC) No 1049/2001, access cannot be granted to the personal data contained in the requested documents, as the need to obtain access thereto for a purpose in the public interest has not been substantiated and there is no reason to think that the legitimate interests of the individuals concerned would not be prejudiced by disclosure of the personal data concerned.

Regarding documents 1.7, 1.8, 1.9., 1.10, 1.11, 1.12, 1.13, 1.14, 17.3, 24.3, 27.3, 30, 31, 32, 33, 34, 35, 36, 37, 38 and 39, I regret to inform you that your application cannot be granted, as disclosure is prevented by exceptions to the right of access laid down in Article 4(2) first indent of this Regulation. The aforementioned documents contain sensitive business information and their disclosure would undermine the protection of the commercial interests of the contractor. For these reasons, the exception laid down in Article 4(2) first indent of Regulation (EC) No 1049/2001 applies to these documents.

I have considered whether partial access could be granted to documents 1.7, 1.8, 1.9., 1.10, 1.11, 1.12, 1.13, 1.14, 17.3, 24.3, 27.3, 30, 31, 32, 33, 34, 35, 36, 37, 38 and 39. I concluded that it is not possible to grant partial access because the documents are covered entirely by the exceptions mentioned above.

Concerning the parts of the documents falling under the exception of art. 4(2) first indent, I would like to point out that the exceptions laid down in Article 4(2) and 4(3) of Regulation (EC) No 1049/2001 apply unless there is an overriding public interest in disclosure of the documents. It was examined whether there could be an overriding public interest in disclosure, but such an interest could not be identified.

In accordance with Article 7(2) of Regulation (EC) No 1049/2001, you are entitled to make a confirmatory application requesting the Commission to review this position.
