ARTICLE III.1: SUBJECT

III.1.1 This specific contract implements Framework Contract No 30-CE-0454145/00-50 signed by the Commission and the Contractor on the 30 november 2011.

III.1.2 The subject of this specific contract is financial audits

III.1.3 The Contractor undertakes, on the terms set out in the Framework Contract and in this specific contract and the annex thereto, which form an integral part thereof, to perform the financial audits as specified in Annex A.

ARTICLE III.2: DURATION

III.2.1 This specific contract shall enter into force on the date on which it is signed by the last contracting party

III.2.2 The duration of the tasks shall not exceed **7 months**. Execution of the tasks shall start from date of entry into force of this specific contract. The period of execution of the tasks may be extended only with the express written agreement of the parties before such period elapses.

ARTICLE III.3: PRICE

III.3.1 The total amount to be paid by the Commission under this specific contract shall be **EUR 257.550 (two hundred fifty seven thousand five hundred and fifty)** covering all tasks executed.

III.3.2 In addition to the price no reimbursable costs are foreseen
