6. is coated paper exempted from the Directive?
7. if packets & wrappers can be considered a subcategory of Food containers, are they exempted if sold in multipacks?
8. yogurt container – will it fall under the scope of the SUP-Directive?
9. are Beverage cups and beverage bottles subgroups of beverage containers?
10. How the Commission will follow the implementation at national level of the Directive and ensure there is no over-implementation?

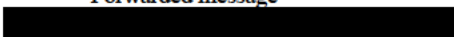
