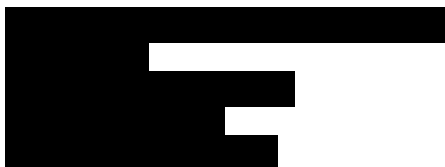
Dear Filip,
