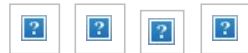

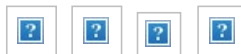

I hope you have had a nice and relaxing summer vacation, notwithstanding the enduring difficulties of the Covid-19.

Following up on my last email (here below), I would like to ask you whether you think we can get an appointment for a video call with Commissioner Valean and yourself, to explain the 'Clean Fuels for All' strategy that we launched in June last.

Particularly now that you are busy with the preparation of the Sustainable and Smart Mobility: it is important for us to let you know about the **evolution of refineries** we have studied. We have the concrete possibility to **progressively stop the use of crude oil, and replace in 2050 all the fossil fuels by sustainable, "net zero CO2" fuels**. These fuels, side-by-side with electrification and hydrogen, would allow **transport to become climate neutral in 2050**.

Please advise whether this request of mine is sufficient, or whether [REDACTED] should send an official letter to Ms. Valean.
