I hope you are doing well in these (still) difficult times!  
Two quick points:

- Refinery Forum on 18 February: DG ENER has confirmed to us that they got in contact with Ms. Valean's Cabinet (you?), to invite her to give a short address at this event. It would be great if the Commissioner could intervene at the Forum. As you can see from the attachment, the speakers list is high level: Commissioner Simson, [REDACTED], an MEP (tbd), the [REDACTED] of IndustriAll, two leading executives from fuel companies and others. Ideally, the intervention of Ms Valean could take place at the end of the Forum, after the conclusion of the session on "Fuels for Climate Neutrality".
- I have seen that Commissioner Valean will speak at the 2 – 3 Feb Eurelectric's E-Vision event. As we have planned a meeting with you on 27 January (main subject: the Renewable and Low-Carbon Fuels Value Chain Alliance), [REDACTED] and I would be happy to share also our latest idea: how a new hybrid/ICE, combined with a lifetime supply of renewable fuels, could be labelled "zero GHG emissions" and be treated similar to a BEV. If you will find it interesting, you could share these ideas with Ms. Valean before her participation to the e-Vision.
