Merete Juhl started in Danish Agriculture and Food Council 1. August 2022.

Merete Juhl is former Danish diplomat and former ambassador in several countries – most recently Lebanon and Jordan at the Danish embassy in Beirut.

In 1998, Merete Juhl studied a master's in European Politics at the College of Europe in Bruges and in 1999 became a candidate in political science from Aarhus University. During the course, she was on a study stay at the Agricultural Council in Brussels and at Harvard University in the USA.

From 2000 until 2022, Merete Juhl was employed by the Ministry of Foreign Affairs. The employment entailed a series of international positions and secondments. Since 2013, Juhl has held three ambassador positions – first in Ukraine, Georgia and Armenia, then in the United Arab Emirates and finally, since 2018, in Lebanon and Jordan.
