Regarding our phone call a moment ago –

The Industry and Climate Committee of Finland Chamber of Commerce will visit Brussels on 27th and 28th of February. Our aim is to discuss the finalization of the EU Green Deal and acceleration of the European green transition.

We would very much appreciate if you and your colleagues would have the time to meet with us to discuss especially EU's response to the US IRA package. As you might know, Finnish business community has been quite worried about the possible easing of state aid rules. The Green Deal Industrial Plan offers also good elements to increase our competitiveness from increasing access to clean energy, faster permitting and securing raw materials.
