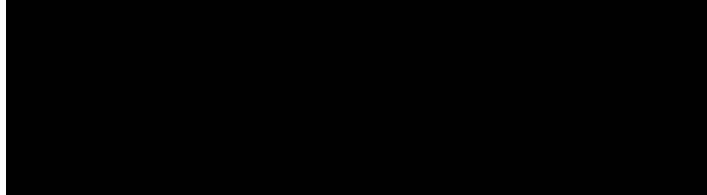
On behalf of the Cobalt Institute – the global trade association representing the interests of Cobalt producers, users, recyclers and traders – I would like to request a meeting to discuss how the EU can secure long-term and responsible access to strategic raw materials like cobalt through international partnerships such as the Global Gateway initiative.

Cobalt is a critical raw material and will be essential for Europe's green transition. Europe will rely on imports from countries like the Democratic Republic of Congo (DRC) where 65% of known reserves lie. We see that initiatives like the Global Gateway are well placed to support cobalt sourcing and infrastructure in sourcing nations, such as the DRC. This will in turn enhance relations with local governments and would allow industry to play an active role in improving the responsible sourcing standards.

We would be grateful to meet with you to share our expertise and experience of working with the DRC and discuss the kinds of investment that can make a real difference to the security and sustainability of the supply of important raw materials. We are also aware that this will be discussed in the European Development Days on 21-22 June and would like to offer our support in the context of that event.

Please let us know whether a virtual or an in-person meeting could be arranged in the upcoming weeks.
