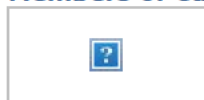

We have made a very difficult decision to **cancel the in-person trip late last night**, also in the context that the US is considering suspending airspace with countries

affected by the newest variant.

This is of course very disappointing, but we would like to request whether we could organise a virtual meeting instead? While this cannot replace an in-person dialogue, we hope that such meeting can be organised as there is several important priorities (also in the space of hate speech as discussed with your team) that Nick would be very keen to address with you.
