I hope this message finds you well. Following the meeting we had in January between your team and CAOBISCO on Farm to Fork – health and nutrition related items, I would like to ask if there are updates on expected Farm to Fork activities for Q3/Q4 2021, in particular regarding the following topics:

- Front of pack nutrition labelling
- Nutrient profiles to restrict promotion of food high in salt, sugars and fats
- Reformulation and setting maximum levels for certain nutrients

We are aware that EFSA opinion on FOPNL and Nutrient Profiles is expected by March 2022 and a public consultation by end of 2021, but would you have more information on the status of the Inception impact assessment of the FIC regulation?
