I hope that you are both going well.

I would like to inform you that we have further progressed on a FEDIOL dossier to address vegetable oils and fats in the Nutriscore. This is in line with discussions we had earlier and previous documents we shared with you.

Our FEDIOL dossier, which you will find attached for your information, has been submitted to the Nutriscore Steering Committee for their review and assessment following the setting up and mandate of the transnational Nutriscore body .

This does not change our FEDIOL position, as provided to the Commission consultation on the Roadmap earlier this year. However, with the introduction of the Nutriscore in a number of countries in recent years, we felt it important to highlight our views as regards vegetable oils and fats, as we consider that the current Nutriscore is currently not in line with existing EU nutrition and health claims and with national and international dietary guidelines.
