**Subject: Your request for access to documents under Regulation (EC) 1049/2001<sup>1</sup>**

Dear Mr Le Querrec,

On 23.08.2023, you sent an access to documents request to the European Data Protection Supervisor (“EDPS”) based on Regulation (EC) No 1049/2001. On 28.08.2023, we sent you an acknowledgement of receipt for your request also mentioning the deadline in accordance with Article 7(1) of Regulation (EC) 1049/2001.

Your request for access to documents concerns “[a]ll internal working documents that would not have been made public containing comments, presentation material (powerpoint, etc.) and legal analysis from the EDPS on the proposal for a Regulation on preventing the dissemination of terrorist content online (COM(2018) 640 final), produced prior to formal comments of the EDPS on 12 February 2019. This shall include, but is not limited to, internal emails, background/briefing notes, and minutes of meetings”.

### **Data Protection Notice**

*According to Articles 15 and 16 of Regulation (EU) 2018/1725 (the Regulation) on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, we are processing your personal data, where proportionate and necessary, for the purpose of answering your request. You have the right to access your personal data held by the EDPS and to relevant information concerning how we use it. You have the right to rectify your personal data. Under certain conditions, you have the right to ask that we delete your personal data or restrict its use. We will consider your request, take a decision and communicate it to you.
